1. Apologies for absence

2. Minutes of previous AGM, September 25, 2020.

Minutes of the previous meeting had been sent out to members on email. No comments or amendments were received via email, or from AGM attendees on the day. Andrena Telford proposed that we accept the minutes. Margaret Wilson seconded. These minutes were thus approved as an accurate record.

3. Matters Arising.

There were no matters arising that were not dealt with under subsequent Agenda items.

4. President's Report.

Heather Cordell welcomed NCA members to our first formal face to face event for 18 months. We had inherited a very attractive programme for 2020 and 2021 from Bill and Andrena Telford, but sadly the COVID pandemic prevented us from benefitting from this. However, many of the planned events have been rescheduled for 2022. The President's report had been circulated to members in advance. A summary of the highlights is as follows: We were able to hold three meetings by Zoom: a Quiz in December 2020 and two Zoom talks in 2021 (Ruth Dodds and Tyneside in the 1920s by Margaret Bozic MBE; and The Work of the HALO Trust by Chris Loughran). The Freshers' Party was held on September 17th in Newcastle at the Literary and

Philosophical Society (Lit & Phil). It was well attended with over 40 Freshers, guests and NCA committee members. The event went very well, and we hope that many of the Freshers will join the NCA if they return to the region.

4. Hon. Secretary's Report.

A visit to Farne Islands and Seahouses was planned for the latter but is subject to change [Post AGM Note: the Hon. Secretary's written report was overly confident here]. Dates and venues will be confirmed once we have finalised arrangements.

We also intend to continue to hold informal and online events such as walks, quizzes, and talks, which will provide opportunities for members who continue to avoid indoor gatherings. Members are invited to suggest informal activities.

Website

No comments or questions in relation to the Hon. Secretary's report have been received by email from the membership, and so we can accept that it has met with approval. On behalf of the Association, we record our thanks to Andrena Telford for her work as Hon. Secretary over the years (2010-2020).

5. Membership Secretary's Report.

Currently, we have 170 members, including 6 Honorary and 5 Associate members. Associate members are partners of deceased NCA members who have regularly attended our events, and to whom it is our policy to offer NCA membership and continued access to events. Freshers can also become Associate Members. We have two new members and have had two resignations. We have 140 members on our email list, and 30 on our postal list.

We were saddened to hear of the deaths of Mike Gaunt (Fitzwilliam 1968-71, Law) and Nick Robson (Caius 1954-57, Law). Mike and Nick were remembered in the July newsletter.

The secretary thanked members who had paid their subscriptions for 2021 and invited those who have not yet paid their £10 to do so soon.

6. Hon. Treasurer's Report.

The Treasurer's report had already been circulated, along with the Audited Financial Statement for August 1, 2019-July 31, 2020, and the Auditor's Report.

COVID restrictions have resulted in limited financial activity. A surplus of income over expenditure has resulted from a reduced call on subscription income, especially for venue deposits that are required in advance of events. Printing costs have also been reduced.

Due to an error in combining the reports into a single AGM document, the Income and Expenditure details of the accounts could not be covered at the AGM. These were available in the accounts spreadsheet on the website. The Secretary apologised for this error and promised to correct it on the website.

A question about debtors resulted in clarification that these are others' debts to the NCA that take the form of deposits paid in 2020 for events that will now take place in 2021 or 2022.

[Post-AGM note: a correct version of the combined reports was uploaded to the website. NCA members were notified on September 30, 2021 as part of the email sending the forms for the remaining 2021 events].

7. Auditor's Report.

The Hon. Auditor, Vinny Holden, had audited our accounts, and his statement to that

effect had been circulated in advance. The auditor has confirmed that the balance sheet and income and expenditure account presented by the Treasurer were accurate and reflected the current position of the bank account.

No comments, questions, or suggestions in relation to the Association's finances were received by email from members, and the Treasurer's report, the financial statement for 2019-20 and the Hon. Auditor's report can all, therefore, be accepted. On behalf of the Association, we record our thanks to Susan Austin for her excellent work as Treasurer, and also to our Hon. Auditor.

8. Election of Officers and Executive Committee.

All officers and ex-officio members have indicated their willingness to continue as Executive Committee members. A new member, Ian Lawley, has volunteered to join the committee. Information about Ian was included in the AGM papers for members. The President asked members to approve the continuation of the existing committee and the addition of Ian Lawley. Kate Hilton proposed that members approve, seconded by George Hopper. The existing committee will thus continue, joined by a new ex-officio member.

9. Any Other Business.

The first formal face to face NCA event for 18 months provided a much-awaited opportunity for the current President to personally thank the former President and Secretary, Bill and Andrena Telford, for their extended excellent service to NCA members. They have been thanked with gifts and a newsletter article in January 2021. However, with Bill and Andrena attending the AGM, members were able to thank them with a very appreciative round of applause.

President's Report 2021-22

I am pleased to report that in the past year (since September 2021) we have resumed our usual full programme of in-person events, all of which have been announced via email or through the NCA website: http://www.northumbrian-cambridge.co.uk/. Following the 2021 AGM, we welcomed Dr David Gosling, Clare Hall, Cambridge, to give us a lecture entitled 'Violence and hope on Pakistan's border: an educational encounter'. In November members attended a concert at the Sage (The People's Requiem) performed by the Royal Northern Sinfonia, Chorus of Royal Northern Sinfonia (including myself!) and over 200 musicians from the North East community. In December we enjoyed our usual Christmas Lunch at the County Hotel and Festive Tea and Film (Meet Me in St Louis) at The Tyneside Cinema. We started 2022 with a Winter outing to Bellingham Heritage Centre and held our Annual Dinner at the Northern Counties Club. These were followed by two Spring outings (to Kirkley Hall Zoological Gardens and Raby Castle) and a Summer Outing to Brancepeth Castle. We also held an informal walk in the Tyne Valley.

We were deeply saddened by the death on May 19 of Dr Andrena Telford, former NCA Secretary. Together with her husband, our former President, Dr Bill Telford, she was an active and much-valued member of the society, as well as of many other societies (e.g., the National Association of Women's Clubs, the National Council of Women, the Friends of the Laing Art Gallery, and the John Buchan Society) in many of which she held leadership and/or administrative roles. Several NCA members attended Andrena's funeral which took place at Newcastle Crematorium on June 7.

The current Committee members are all willing to continue for another year and, in addition, Joanna Quinton has agreed to stand for election to join us. The constitution states that there should be not more than seven nor less than five non-ex officio members, so, with the addition of Joanna, we are now at capacity (but we would welcome expressions of interest from other prospective future Committee members). The Committee hopes that all members attending the AGM will approve the new Committee, and give them your support.

Membership Secretary's Report 2021-22

Current membership stands at 167, including 6 Honorary and 5 Associate members. Associate members are partners of deceased NCA members who have regularly attended our events, and to whom it is our policy to offer NCA membership and continued access to events. We have 141 members on our email list and 26 on our postal list.

We are sad to report the deaths of David Hide (Trinity 1950-53), Dr Betty Schofield (Newnham 1938-41, Medicine) and Dr Andrena Telford (Dept. Adult Education, English Literature Teaching, 1972-77), our wonderful NCA Secretary for over ten years.

We offer free Associate membership to students attending our Freshers' Welcome Party, and now have 72 students on our list (2019: 25; 2020: 1; 2021 29; 2022 17). It is hoped they will become full members should they return to the area in the future.

We would encourage any members who have not yet paid their £10 subscription for 2022 to do so as soon as possible, or to let the Membership Secretary know if they wish to resign.

Treasurer's Report 2021-22

This report accompanies the financial statements for the year ended 31 July 2022 (on the following two pages of these AGM papers).

Subscription income has happily increased this year, with the waning of the pandemic, though it is still down on 2019. Around 90% of subscriptions are now paid electronically (by Standing Order or bank transfer).

Bookings for events have also been encouraging and we had excellent attendance at the Freshers' welcome party with an outlay of £318. The deficit on the 2021 AGM results largely from guest lecturer's travel and accommodation expenses and venue hire, with attendance being somewhat lower than in pre-pandemic years.

The deposits of £695 made in 2019 and 2020 - relating to the Christmas Lunch, Festive Tea & Film, Freshers' reunion and Raby Castle – have been set against these events which were finally able to go ahead.

A surprise expense came in the form of HSBC's decision to rename association and community accounts as Charity Accounts and charge a fee of £5 per month for account maintenance with additional charges for cheque transactions. It transpired that notification of the changes and other information had been sent to a previous account signatory. Following a letter of complaint, HSBC has paid £100 in compensation and refunded four months' accounts maintenance fees.

This was merely the latest incident in a long-running saga, hence the decision to open a new account with Lloyds bank and close the HSBC account.

Other administrative expenses are in line with earlier years and printing costs have been significantly reduced. The outturn for the year is a deficit of £175.73, a good result for a year of some uncertainty. The Association remains in a sound financial position.
